No.CCIM-Election-2015/30.—Notice is hereby given pursuant to the provisions under clause (a) of sub-section (1) of section 3 of Indian Medicine Central Council Act, 1970 (48 of 1970) and under clause 5 of Indian Medicine Central Council (Election) Rules, 1975 that —

(1) An election is to be held for Six members (05 Ayurveda and 01 Unani) of the Central Council of Indian Medicine, to be elected from State of Maharashtra by the registered medical practitioners registered at Maharashtra Council of Indian Medicine from amongst themselves;

(2) Nominations of Registered Practitioners, registered and having updated renewal in Maharashtra Council of Indian Medicine and residing in the State of Maharashtra are eligible to fill the seats are invited;
